



PESHAWAR Scribe killed in Pakistan

A senior Pakistani journalist has been killed by unidentified gunmen near his residence in Khyber Pakhtunkhwa province, police said on Wednesday. Khali Jibran was targeted by miscreants on a motorcycle when he was heading towards his residence with his friend in Landi Kotal town of Khyber district on Tuesday. The gunmen dragged him out of his vehicle and opened fire at him. Jibran died on the spot.

DHAKA Nine die in landslides

At least nine persons were killed at Rohingya camps in rain-triggered landslides which also damaged many dwellings in south-eastern Bangladesh on Wednesday, a senior official said. Mohammad Samsuduzzaman, additional refugee relief and repatriation commissioner, said that the landslides hit Camp No. 9 and 10 in Cox's Bazar district, 292km southeast of Dhaka.

MOSCOW Russia jails US soldier

A court in Russia's far eastern city of Vladivostok on Wednesday convicted a visiting American soldier of stealing and making threats of murder, and sentenced him to three years and nine months in prison. Staff Sergeant Gordon Black, 34, flew to the Pacific port city to see his girlfriend and was arrested last month after she accused him of stealing from her, said US officials and Russian authorities. News agencies reported that the judge also ordered Black to pay \$115 in damages.

Ukrainian drones hit oil depot in Russia, setting it on fire

Ukrainian drones hit an oil depot in Azov in Russia, leading to a large fire in a fuel tank in the oil terminal. The fire in the southern port in the Rostov region of the country was contained in an area of 3,200 square metres, local media quoted regional emergency services as saying on Wednesday. Four Ukrainian combat drones were reportedly involved in the attack on the oil depot that was carried out by the Security Service of Ukraine, a media report quoted an official of the country as saying. "Powerful fires broke out at the facilities after the successful deployment of SBU drones," the Ukrainian official said, adding that the SBU agency would keep attacking Russia's oil refining complex to

550 pilgrims die during Hajj

At least 550 pilgrims have died during the Hajj, with most of them succumbing to heat-related illnesses, officials said on Wednesday. At least 323 of those who died were Egyptians, one official said, adding that the deaths underscored the grueling nature of the pilgrimage that again unfolded in scorching temperatures this year. "All of them (the Egyptians) died because of heat" except for one who sustained fatal injuries during a minor crowd crush, said an Arab diplomat.

Agencies SAUDI ARABIA

At least 60 Jordanians have died, an official said. Amman had on Tuesday given an official tally of 41. Other countries to report deaths during the Hajj this year include Indonesia, Iran and Senegal. However, most countries have not specified how many deaths were heat-related. Saudi Arabia has not commented on the toll. On Tuesday, Egypt's foreign ministry said Cairo was collaborating with Saudi authorities on search operations for Egyptians who had gone missing during the Hajj. Saudi authorities have re-

The Hajj is increasingly affected by climate breakdown, according to a Saudi study published last month that said temperatures in the area where rituals are performed were rising 0.4C each decade. Temperatures hit 51.8C at the Grand Mosque in Mecca on Monday, the Saudi national meteorology centre said. Pilgrims outside Mecca were seen pouring bottles of water over their heads as volunteers handed out cold drinks and fast-melting chocolate ice-cream to help them keep cool. Saudi officials had advised pilgrims to use umbrellas, drink plenty of water,

All-out war decision soon: Israel minister

Agencies BEIRUT & JERUSALEM

Israeli Foreign Minister Israel Katz warned on Tuesday that a decision on an all-out war with Hezbollah was coming soon, even as the US tries to avert any escalation. US envoy Amos Hochstein was sent to Lebanon to try and cool tensions following an increase in cross-border fire along Lebanon's southern frontier that has escalated to Hezbollah hunting it could attack Haifa, Israel's third-largest city. Iran-backed Hezbollah has been trading fire with Israel for the last eight months in parallel with the Gaza war. Last week, the group fired the largest volley of rockets and drones of the hostilities so far at Israeli military sites, after an Israeli strike killed the most senior commander yet. Foreign Minister Israel Katz said in an X post that in the wake of threats by Sayyed Hassan Nasrallah, the group's head, to damage Haifa's ports that are operated by Chinese and Indian companies, "we are getting very close to the moment of deciding on changing the rules of the game against Hezbollah and Lebanon."



"In an all-out war, Hezbollah will be destroyed and Lebanon will be severely beaten," he added. Israel's military later said they were fully prepared. Hezbollah says it will not halt its attacks unless there is a ceasefire in the Gaza Strip. A Pentagon spokesperson said the United States did not want to see a wider regional war in the Middle East. Hochstein said he had been dispatched to Lebanon immediately following a brief trip to Israel because the situation was "serious". "We have seen an escalation over the last few weeks. And what President Biden wants to do is avoid a further escalation," Hochstein said.

Russia, N Korea ink deal for mutual aid

Russian President Vladimir Putin and North Korean leader Kim Jong Un signed a partnership that includes a vow of mutual aid if either country is attacked, during a Wednesday summit that came as both face escalating standoffs with the West. The deal, which the leaders said covered areas including security, trade, investment, and cultural and humanitarian ties, could mark the strongest connection between Moscow and Pyongyang since the Soviet Union collapsed in 1991. Both leaders described it as a major upgrade of their ties. Kim said that the deal was the "strongest ever treaty" between the two nations, putting the relationship at the level of an alliance, and vowed full support for Russia's war in Ukraine. Putin said that it was a "breakthrough document" re-

Agencies WASHINGTON

Switchblade missiles and accompanying fire control systems worth \$60.2 million, said a release from the US Defense Security Cooperation Agency (DSCA) on Tuesday. The US will also provide Taiwan with up to 291 Altus 600M loitering munitions and supporting components with a price tag of \$300 million, the DSCA said.

US okays sale of 1,000 drones to Taiwan

The US has approved the \$360 million sale of more than 1,000 small armed drones to Taiwan, as the self-ruled island claimed by China aims to strengthen its asymmetrical warfare abilities with an eye on successful tactics used in Ukraine. Taiwan will receive 720

The proposed sale comes as China increases military pressure on Taiwan, with extensive military exercises around it and most daily warplane flights near the island. China's ruling Communist Party claims democratic Taiwan as its own, despite never having controlled it, and has vowed to "reunify" with the island, by force if necessary.

The defence alliance takes decisions by consensus, so any candidate needs the support of all 32 allies. Only Romania, whose Prez Klaus Iohannis is also vying for the job, is still opposed to Rutte's candidacy. Stoltenberg neither confirmed nor denied the report. "With the announcement of (Hungarian) Prime Minister (Viktor) Orbán, I think it's obvious that we are very close to a conclusion... to select the next secretary-general and I think that's good news," he said while praising Rutte.

Iran imprisons Nobel Peace Prize winner for another year

Iran's imprisoned Nobel Peace Prize laureate, Narges Mohammadi, has been sentenced to another year in prison over her activism, her lawyer said on Wednesday. Mostafa Nili, Mohammadi's lawyer, said his client was convicted on a charge of violating propaganda against the system. The sentence came after Mohammadi urged voters to boycott Iran's recent parliamentary election, sent letters to lawmakers in Europe and made comments about Iran's

and sexual assault suffered by another Iranian journalist and political activist, Nili said. Mohammadi is being held at Iran's notorious Evin Prison, which houses political prisoners and those with Western ties. She already had been serving a 90-month sentence, to which 15 more months were added in January. Iran's government has not acknowledged her additional sentencing. Mohammadi is the fifth woman to win the Nobel Peace Prize and the second Iranian woman after human rights activist Shirin Ebadi to win the

has kept up her activism despite numerous arrests by Iranian authorities and years behind bars. In November, Mohammadi went on a hunger strike over being blocked along with other inmates from getting medical care and to protest the country's mandatory headscarves for women. Mohammadi was a leading light for protesters, who held fast for 15 days after the death last year of a 22-year-old woman in police custody that have grown into one of the most intense challenges to Iran's theocratic government.
